# Message from the Chief Operating Officer

We have reached the end of another year – action packed with many challenges and difficult trading conditions influenced by the impact of government activities on the economy, and a general lack of confidence in the country. However, at Thorburn we kept focusing on our business standards, our staff, and business retention through our service levels.

This year saw the last of our three-year industry wage increase cycle with major changes to Grade D wages becoming equal to Grade C wages, and a reduction in the wage areas from 3 to 2. A challenge in 2018 will be the implementation of the **Minimum Wage Act** which could see minimum wages in the industry rising, resulting in an impact on the private security industry and the consumers of security.

2017, as our second year as a **Tsebo Solutions Group** subsidiary, was exciting and integration into the Tsebo Solutions Group is taking shape. Exciting opportunities entering the markets of sister divisions in cleaning, catering and facilities management prevail. Whilst our focus is on national expansion, African expansion is on the cards in the not too distant future.

I am very grateful for the contribution made by our security teams in 2017 – it is never easy, and the criminal onslaught has become more militant, executed by armed gangs endangering the lives of our personnel. Operational successes prevailed and improved in the past year. Many an efficiency has been exploited and the streamlining of our time and attendance with biometric systems allowed us to capture more accurate attendance data, with live status reporting. In the latter part of 2017, a strategic decision was taken to aggressively drive the provision of intelligence driven integrated security solutions – a concept which you will hear about and see early in 2018. The year also saw many a Security Officer being developed to higher levels and enrolled in internal Management Development Programs (bridging course) under the auspices of the Tsebo Skills Academy, with the intent of a national rollout in 2018. The Thorburn participation in the external GIBBS Management Development Program has tripled compared to 2016.

A major improvement in our service offering is our philosophy of "One Company, One Brand and One Solution" which means that we create opportunities for our clients to have one point of contact for our solutions offering. It is more especially technical solutions which has integrated into our security solution operations, that underpins the one solution concept. As part of a Tsebo Solutions offering, security will integrate into the broader FM concept, with the one point of contact developing in that sphere as well. A **truly integrated solution** harmonising all solutions into one.

Our focal points for the year ahead include:

- Safety focus elevated to the next level, namely to Participation-Based Safety and the aim of achieving ISO 45 001 standard later in 2018
- Roll out of the Intelligence Driven Integrated Security Solutions concept
- Business retention strategies

# Your most valued asset for thieves - your ID

With all the data breaches, you should expect to be the target of identity theft - and you should be taking protective action. Identity theft is the crime of getting the personal or financial information of someone so that the criminal can be approved for credit or make purchases in that person's name. **ALL** South Africans are at risk, don't be a victim of fraud! While we have tools to protect ourselves in the physical world, in the digital world we aren't as aware of the dangers to which we're exposed.

**GOLDEN RULES FOR GUARDING YOUR IDENTITY:** 

- 1. Don't leave your ID lying around or give it to someone
- 2. Don't respond to requests to update your personal info over the phone
- 3. You have NOT won the prize, ever!
- 4. Don't be rushed into parting with personal information
- 5. Don't click on links you haven't initiated. Your bank will never send you an e-mail or an SMS asking you to click on a link to access your online banking platform!

# Private Security in South Africa today

It is widely known that SA is one of the most unsafe and dangerous countries, which has given rise to one of the biggest private security force in the world. The latest numbers from PSIRA show that SA currently has **500,000 active Security Officers**, with over 1.5 million registered Officers. This is far higher than the SAP and the military, combined.

The number of security providers in SA has increased from **8,830** in 2016 to **8,995** in 2017 – an addition of 165 new service providers.

# Metrorail fined heftily for Security Contraventions

The commuter rail service company has fallen foul of the private security industry regulatory authority (PSIRA), which regulates the private security industry and ensures that security service providers act in the public and national interest, in the interest of the private security industry itself.

It is alleged 80% of Metrorail security staff are not PSIRA registered. According to the Security Industry Regulation Act, no person or security company may render a security service for remuneration, reward, a fee or benefit, unless such a person or company is registered as a security service provider in terms of the Act. All companies or individuals who work in the private security sector must be registered with PSIRA. Many users of security are not aware of this or the implication which could lead to prosecution and/or fines,

# Estates cannot issue traffic fines or curfews

Private estates may not enforce road traffic law. This was the finding of the KZN High Court, bringing to an end the long-held view of private residential estates that they may set speed limits and erect road signs without abiding by the restrictions of the National Road Traffic Act. It also ensures that enforcement can only be carried out by a traffic officer who is authorised by law to do so. The roads within the majority of gated communities fall directly within the definition of a 'public road' and only duly authorised persons and/or bodies may erect road traffic signs. Where a private estate wishes to erect its own road traffic signs, authorisation may only be granted by the Minister of Transport, the MEC, or a person who is delegated such powers by the Minister or the MEC.


## Safety remains a challenge in the Security Industry

Our industry deploys 40,000 vehicles (driving 120mil km's); consumes 24mil liters of fuel; uses 40,000 boxes of paper; 30,000 pens; pays R140mil in wages and contributes more than R5,6mil (all monthly) to the Workmen's Compensation Fund. Add to this 500,000 potential safety risks. Conversely that means 500,000 people that could potentially save businesses from 500,000 potential safety incidents by hazard identification each month.
